IPMA Level C, B, or A can only be applied for at the same time of initial application. IPMA RPL&A Levels C, B, and A are charged cumulatively on top of Level D.</p> <p>RPL&A assessment is subject to IPMA CVMB approval and may be subject to conditions of approval imposed by IPMA. No guarantee can be made by IPMA-Australia (CB) of final approval as it is only able to support the Application Body engagement of RPL&A to IPMA.</p>
