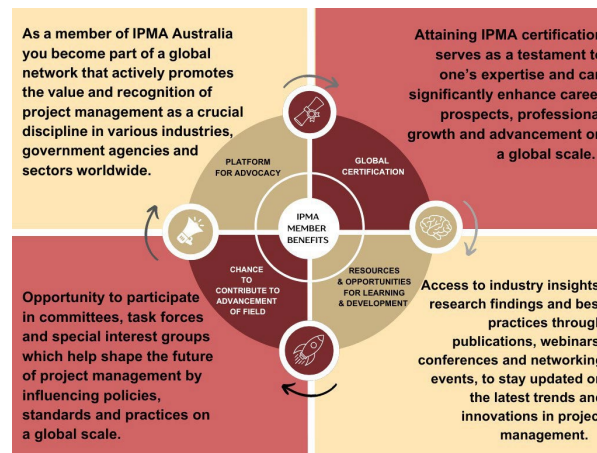

<i>Student</i> – currently undertaking training in a recognised PM course *Membership is free for the first year if you undertake a IPMA certification.	\$50
<i>Associate</i> – (working in a project environment) *Membership is free for the first year if you undertake a IPMA certification.	\$200
<i>Full Member</i> – (working in a project management environment and has at least 5years project management experience) *Membership is free for the first year if you undertake a IPMA certification.	\$300
<i>Fellow Member</i> – (by application only that reflects experience, advocacy for the profession and commitment to professional development) *Membership is free for the first year if you undertake a IPMA certification.	\$450
<i>Honorary Fellow</i> – (by invitation only that reflects leaders in project management)	TBA
